Further to the notification of Privredna banka Zagreb d.d., with registered office in Zagreb, Radnička cesta 50, TIN: 02535697732 (hereinafter: „the Bank“), of 26 April 2021 relating to decisions of the General Meeting of the Bank, we would like to inform the investment public that the Decision on the withdrawal of the shares of Privredna banka Zagreb d.d. from the regulated market - Zagreb Stock Exchange Inc. was entered in the court register of the Commercial Court in Zagreb on 5 May 2021 and that it thus entered into force.

The Bank will buy out the shares, at a fair price, from all the Bank's shareholders who voted against the Decision on the withdrawal of the Bank's shares from the regulated market of Zagreb Stock Exchange Inc. at their request, and will do so no later than three months from the date of entry of the Decision in the court register of the Commercial Court in Zagreb.

Today the Bank has submitted to Zagreb Stock Exchange Inc. a request for the withdrawal of shares from listing on Zagreb Stock Exchange Inc. and has delivered the Decision to the Commercial Court in Zagreb.
