Each copy of this electronic document shall be deemed an original, shall have the same legal force and shall produce the same legal effect as a paper document signed with a handwritten signature and may be used in all actions which require the use of documents in their original form, and shall not be denied legal effect and admissibility solely on the grounds that it is in electronic form. The User shall not contest the legal force of a qualified electronic signature on this Application Form merely because it has been drawn up, used, circulated and signed in electronic form.
